

e. Special Operations

Throughout the reporting period VMFA-251 was commanded by Lieutenant Colonel J. C. BYRAM JR. During the six month period the squadron flew 1262 sorties and 1,664.0 flight hours accomplishing 621 syllabus training credits.

In the month of September, after participating in air intercept training operations with the USS Albany, the squadron deployed with nine aircraft to NAS Key West, Fla. for operational and training flight operations. The deployment which ended on 14 October 1972, yielded 85 syllabus training credits in 329 sorties and 388.2 hours.

During the month of November 1972 the squadron conducted a diversified aircraft training program. In addition to day air combat maneuvering and night radar intercept missions, the squadron devoted 30,8 flight hours to SAIS operations at Bogue Field, N.C. The squadron then participated in the 20th NORAD Exercise "SNOWTIME". Flight operations also included live ordnance Close Air Support Training.
